2027 School Terms

Terms & Conditions

Payments are made subject to the following terms and conditions.

1. If payment is not received as elected above, or any single instalment by the first of the month, the account will fall into arrears and outstanding fees become immediately due and payable. Your child may not return to school until fees are received.
2. I authorise Giggle and Grow to conduct credit bureau searches on me, and to inform any relevant credit bureau and have my/our name listed with them in the event of non-payment.
3. Written notice is required when withdrawing a child from the school, provided one full term ahead. Should notice to cancel be received: (a) you remain liable for the current term's school fees; (b) you remain liable for any fees outstanding up to the date of cancellation; and (c) a reasonable cancellation penalty may be charged.
4. I/We choose the residential address(es) given under Personal Details as my/our chosen legal domicile for service of all legal notices and procedures, until I/we advise the school in writing of a new address.
5. Where I/we are not the natural parent(s) and/or guardian(s) of the child, I/we accept the responsibilities of parents as defined in Section 1 of the Schools Act.
6. Receipts are available on request or on date of payment; a year-end statement will be provided by 31 December.
7. By signing this contract, all parties agree to have read, understood, and accepted all policies, procedures, terms and conditions herein. This agreement is in effect from 1 January 2027.

Providing false information may be grounds for termination of childcare services. This is a legally binding agreement.
